Re: Call for Board Nominations

- A half page biographical profile
- A brief position statement of not more than 500 words. In this position statement, nominees will be asked to address two questions:
- a. What is your vision for the position?
- b. What is a critical issue that Society members are facing that you think needs to be addressed?
 - A letter attesting to the fact that the nominee understands the requirements of the office and agrees to use his/her best ability to carry out those responsibilities, agrees to support and further the Society vision and mission, and has the support of his/her

employer to participate fully in the Society board as required by the duties of the office sought.

Members will be notified of nominees who meet the criteria by the 14th of March 2016. The election of new members of the Board of Directors will take electronically during March and early April and will be announced during the AGM on the 15th of April (during the Society's biennial conference in Johannesburg).
